COVID-19 SAFETY REGULATIONS:

All participants (including exhibitors, visitors, booth construction personnel, exhibit transport truck drivers, etc.) should produce a negative nucleic acid test result taken **within 24 hours** for check in and wear masks during the whole process.

In particular, freight drivers leaving from outside Guangdong province and exhibitors planning to move in on August 15 should complete nucleic acid testing in Guangdong **one day before** entering the exhibition Hall.

Site 1: Hall 6.1. Time : Aug 13-18, 9:00-18:00

Site 2: Sidewalk between Gate 5 and Gate 6. Time: Aug 15-17, 8:00-17:00
